After lengthy preparation, detailed verification and strict audit process in the past 18 months, MUI has issued Halal Decree documents for the categories: (1) meat and poultry products with hyfresh brand (Certificate No. 00010103420420); (2) fruits and vegetable products with hyfresh brand (Certificate No. 00190103170320); (3) bakery products with Bakemart brand (Certificate No. 00200103450420); (4) ready-to-eat products with Delibon Café brand (Certificate No. 00160103310320); and (5) service and retailer which include 102 Hypermart stores, 23 Foodmart & Primo stores, 8 Hyfresh stores, 12 FMX stores and 1 SmartClub, 3 Distribution Centers and Head Office with Implementation Status of HAS of "A" rating (excellent). MPPA will also propose halal certification for upcoming new stores to be opened in the future.

With the application of this HAS, MPPA is committed to maintaining the halal integrity of products that have received MUI halal certificates and supplier products that have obtained MUI halal certificates or other institutions abroad. With this commitment, MPPA ensures that production activities and facilities at suppliers, delivery of products from suppliers, receipt and storage of products in warehouses, receipt, handling, processing and displaying products in stores, services at cashier checkout and delivery of products to customers' homes meet the criteria of HAS.

Previously, the Company has received certification of ISO 22000:2005 - Food Safety Management System which is integrated with ISO 9001 :2015 - Quality Management System and HAS 23000 & SNI 99001:2016 - Halal Management System into our food safety protocols.
